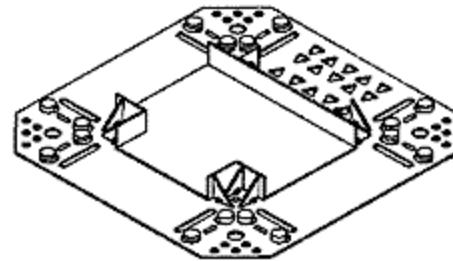

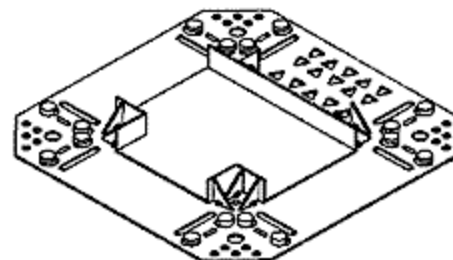

All exterior accessories shall be of PVC material conforming to ASTM standards D1784-92 and C1063-94. Part # _____ shall be used at areas indicated on drawings and used with reveal series 700 manufactured by Plastic Components, Inc. They shall be used where specified by the architect and installed per industry standards and manufacturer's instructions.

Caulk all butt joints, intersections and ends.
It is recommended that PVC products be used for all exterior exposures.
